GIIC Membership Dues Management Regulation

Article 1 According to the *Bylaws of the Global Intelligent IoT Consortium* (hereinafter referred to as "GIIC"), members have the obligation to pay the membership dues on time. To clarify the criteria for the payment and normalize the management of membership dues, the Regulation is developed in accordance with relevant laws and regulations of the country where GIIC is registered and by taking into account the specific rules of GIIC.

Article 2 GIIC only offers entity membership. Members include regular members, Director members, and Vice Chair members. Specific rights and benefits as well as the rules of regulation for GIIC members are formulated by the Board of Directors.

Article 3 GIIC collects membership dues according to the type of membership. A GIIC General Assembly meeting shall be held to develop and modify the membership dues. The Assembly meeting shall be attended by more than two-thirds (inclusive) of the members, And the motion for membership dues shall be approved by more than one-half (inclusive) of the attending members by voting. No person or organization may change the membership dues without going through the procedures and processes stipulated in this Regulation.

Article 4 Membership Dues for GIIC

members are

(1) Vice Chair members: RMB 500,000 per year

- (2) Director members: RMB 100,000 per year
- (3) Regular members: RMB 10,000 per year

Universities and colleges as well as research institutes in members may be exempt from paying membership dues.

Article 5 Membership Dues Use and Management

- (1) The membership dues shall be used for the provision of services to the members and for the development of activitities within the scope of business set forth in the *GIIC Bylaws*.
- (2) The membership dues shall be used according to the financial management rules stipulated by the country where GIIC is registered, with clear procedures for approval and the scope of expenditure, so as to ensure that the membership dues are used in a reasonable and effective manner. The use of the membership dues shall be supervised and audited by relevant finance and taxation departments.
- (3) GIIC shall regularly release the information of income and expenditure to its members, and be subject to the supervision of the GIIC General Assembly.

Article 6 If a member fails to pay the membership dues on time, GIIC is entitled to decide to reduce the service or stop the service to the member. And the member shall not enjoy the priority and preferential rights for GIIC members when participating in the GIIC activities. According to the GIIC Bylaws, if a member fails to pay its membership dues for more than one year without special circumstances, it may be deemed as

a voluntary withdrawal of its membership.

Article 7 The GIIC General Assembly meeting authorizes the Board of Directors to interpret the Regulation, and authorizes the Board of Directors to develop specific management systems, implementation measures or working rules as needed.

Article 8 The Regulation shall take effect upon approval of the GIIC General Assembly meeting by voting.

Appendix:

Rights and Benefits of GIIC Members

According to the related provisions of the *GIIC Bylaws*, the GIIC Member Rules of Regulation, and the GIIC Membership Dues Management Regulation, and in light of the actual situation of GIIC, all types of GIIC members shall enjoy the following rights and interests respectively:

- 1. Regular members of GIIC enjoy the following rights and benefits:
- (1) Participating in the formulation and revision of the standard specifications of GIIC in accordance with the relevant requirements of GIIC's standard management measures;
- (2) Accessing GIIC's working drafts and published standard specifications, in accordance with the relevant requirements of GIIC's standards management measures;
- (3) Participating in the compliance testing and verification of GIIC's specifications and the projects related to testing tools, in line with the relevant requirements of GIIC's testing and certification management measures;
- (4) Using the authorized logos and trademarks of GIIC under the relevant requirements of GIIC's trademark authorization management measures;
- (5) Enjoying the opportunity to display in the publicity activities carried out by GIIC.
- 2. In addition to the rights and benefits of regular members, the Director members of GIIC also enjoy the following rights and benefits:
- (1) Recommending members of the GIIC Strategic Steering Committee;

- (2) Recommending a representative to exercise the voting right for decision-making on the GIIC major matters in the GIIC Board of Directors;
- (3) Initiating and setting up regional branches within the Promotion Committee in accordance with the relevant provisions of GIIC;
- (4) Nominating candidates for the directors of the regional branches initiated;
- (5) Initiating and establishing working groups within the Promotion Committee in accordance with the relevant provisions of GIIC;
- (6) Nominating candidates for the chairs of the working groups;
- (7) Initiating new standard projects and or standard amendment projects in line with the relevant requirements of GIIC's standard management measures;
- (8) Enjoying the opportunities for priority display in the publicity activities carried out by GIIC.
- 3. In addition to the rights and benefits of regular members and Director members, the Vice Chair members of GIIC also enjoy the following rights and benefits:
- (1) Nominating candidates for the Board Chair, Vice Chair, Secretary General and Vice Secretary General;
- (2) Recommending a representative to be the executive director of GIIC (if GIIC sets up the position);
- (3) Nominating candidates for the directors of the Strategic Steering Committee;
- (4) Initiating and establishing the Promotion Committee in GIIC in accordance with the relevant provisions of GIIC;
- (5) Nominating candidates for the directors of the Promotion Committee initiated;
- (6) Initiating and establishing an Industry Committee within the Promotion Committee in accordance with the relevant

provisions of GIIC;

- (7) Nominating candidates for the directors of the Industry Committee initiated;
- (8) Having the right to plan, coordinate and organize innovative activities in the key industries and fields developed by GIIC;
- (9) Having the priority to host or undertake activities organized by GIIC;
- (10) Representing GIIC to attend external meetings and other activities.

This Appendix is issued and adopted at the same time as the GIIC Membership Dues Management Regulation, and GIIC authorizes the Board of Directors to interpret it.
